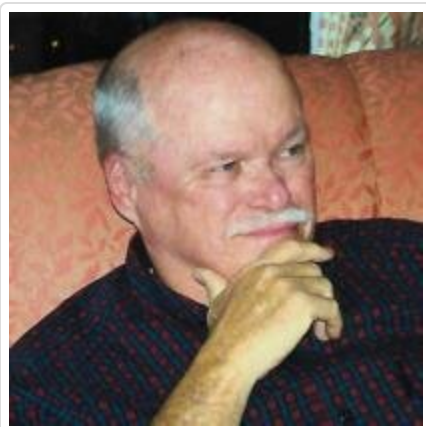




Douglas Mackey
